Whereas, the Board wants to treat the Project as an "other capital project," as such term is defined in N.J.A.C. 6A:26-1-1 *et seq.*, and not request any State financial assistance because there is insufficient time to obtain an approved grant, if such funds are available, from the Department of Education;

Now Therefore Be It Resolved by the Board of Education of the Greater Egg Harbor Regional High School District in the County of Atlantic, New Jersey as follows:

Section 1. The Board authorizes the transfer of \$205,000 from the capital reserve account to the capital projects fund, as permitted under N.J.A.C. 6A:23A-14.1(h)(2), for the purpose of financing the Project.

Section 2. The Board representatives are hereby authorized to take all steps necessary to implement this resolution.
