### 2415.07 TITLE I – ABSEGAMI HIGH SCHOOL PARENTAL INVOLVEMENT

#### GENERAL EXPECTATIONS

Absegami High School will put into operation programs, activities, and procedures for the involvement of parents with Title I, Part A programs, consistent with Section 1118 of the Elementary and Secondary Education Act (ESEA). Those programs, activities, and procedures will be planned and operated with meaningful consultation with parents of participating children.

Consistent with Section 1118, Absegami High School will work to ensure that the required school-level parental involvement policies meet the requirements of Section 1118(b) of the ESEA, and each include, as a component, a school-parent compact consistent with Section 1118(d) of the ESEA.

Absegami High School will incorporate this Parental Involvement Policy into its plan developed under Section 1112 of the ESEA.

In carrying out the Title I, Part A parental involvement requirements, to the extent practicable, Absegami High School will provide full opportunities for the participation of parents with limited English proficiency, parents with disabilities, parents of homeless students, parents of immigrant students and parents of migratory children, including providing information and school reports required under Section 1111 of the ESEA in an understandable and uniform format, including alternative formats upon request, and to the extent practicable, in a language parents understand.

Absegami High School will be governed by the following statutory definition of parental involvement, and expects Title I schools in the district will carry out programs, activities, and procedures in accordance with this definition:

Parental involvement means the participation of parents in regular, two-way, and meaningful communication involving pupil academic learning and other school activities, including ensuring-

1. That parents play an integral role in assisting their child's learning;
2. That parents are encouraged to be actively involved in their child's education at school;
3. That parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child; and
4. The carrying out of other activities, such as those described in Section 1118 of the ESEA.

In the event that the State of New Jersey or the New Jersey Department of Education has a Parental Information and Resource Center, Absegami High School will inform parents and parental organizations of its purpose and existence. Beginning in September 2015, Absegami High School will operate a Parent Resource Center. The Parent Resource Center's goal is to provide resources that will assist, guide, and support parents with their children's education and promote parent involvement by encouraging parents to take an active role in their children's education.

5. Absegami High School will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this Parental Involvement Policy in improving the quality of its Title I, Part A schools, as indicated in the School wide Plan. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). Absegami High School, with community stakeholders and parents, will improve academic achievement through the following activities:

1. Absegami High School will, with the assistance of district personnel, provide assistance to parents, as appropriate, in understanding topics such as the following:
  - New Jersey’s academic content standards via individual and group meetings, Web site information, and curriculum documents;
  - New Jersey’s pupil academic achievement standards through Genesis’s Parent Portal and report cards;
  - The New Jersey and local academic assessments including alternate assessments through report card and department mailings, school calendar, school website, individual meetings, parent mailings, and Guidance Department documents;
  - New Jersey’s high school graduation requirements for native and ELL students via Web site information, individual meetings, parent mailings, and Guidance Department documents;
  - Monitoring individual student progress via conferences, progress reports, and report card evaluations; and
  - How to effectively develop partnerships with educators via individual conferences, Title 1 School wide Planning meetings, and “Back to School Night” meetings.

Absegami will provide information and programming during the following activities, such as workshops, conferences, classes, including any equipment or other materials that may be necessary to ensure success.

- a. Parent meetings will be held each year such as: Back to School Night, Financial Aid Night, College Admissions Night, Freshman Parent Orientation, and Title 1 School wide Planning Stakeholder meetings.

- b. During Back to School Night, computers will be made available for parents to sign up for Genesis Parent Portal, which provides online access to their child's grades, attendance, etc.
  - c. Monthly Parent Information meetings are scheduled to include the following topics: technology to support student learning - Naviance, Edline, Genesis, and Google; PARCC and the Common Core; Roadmap to Success; Parental Academic Support; Community Outreach and Partnership with Galloway Township Police Department; and additional topics as requested by parent stakeholders.
2. Absegami High School will provide materials and training to help parents work with their children to improve their children's academic achievement, related to topics listed in 1c.
  3. The school will take the following actions to ensure that information related to the school and parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
    - a. Parent information letters and Guidance newsletters are regularly mailed to the homes as well as posted on the school website.
