2415.04 TITLE I – DISTRICT-WIDE PARENTAL INVOLVEMENT

GENERAL EXPECTATIONS

The school district will put into operation programs, activities, and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with Section 1118 of the Elementary and Secondary Education Act (ESEA). Those programs, activities, and procedures will be planned and operated with meaningful consultation with parents of participating children.

Consistent with Section 1118, the school district will work with its schools to ensure that the required school-level parental involvement policies meet the requirements of Section 1118(b) of the ESEA, and each include, as a component, a school-parent compact consistent with Section 1118(d) of the ESEA.

- The requirements of Part A;
- How to monitor their child's progress; and
- How to work with educators.

- a. Parent meetings will be held each year such as: Back to School Night, Financial Aid Night, College Admissions Night and individual parent conferences as requested.
 - b. During Back to School Night, computers will be made available for parents to sign up for Parent Connect, which provides on line access to their child's grades, attendance, etc.
2. The school district will, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:

4.
